EXPERIMENTAL ENGINE OVERHAUL WARRANTY

*PERFORMANCE ENGINES, INCORPORATED warrants this engine has been overhauled in accordance with current (as of this date) manufacturers approved data except as modified for experimental use. This engine has been overhauled and modified for experimental use only, and may not be installed in a certified aircraft of any kind. Workmanship is representative of the highest standard of the aircraft piston engine industry. Performance Engines, Incorporated will repair or replace, at its sole option, any part or feature which it determines to be defective, subject to the following conditions: This warranty is pro rata upon the engine manufacturers recommended time between overhauls (TBO), indicated below, at a rate of forty hours of operation per calendar month. This warranty does not extend to the new parts or outside services used in this overhaul, which are subject to the warranty policy of each supplier and/or vendor. Customer furnished parts are not covered by this warranty. Damage caused by prop strikes, overheating, inappropriate fuel usage, engine or airframe modifications not authorized by the engine and/or airframe manufacturer, or any other misuse will void this warranty completely. Lycoming engines may not be operated lean of peak per the manufacturers' recommendations. Teledyne Continental engines may not be run lean of peak while the power setting is above 65% of maximum rated horsepower. All claims must be substantiated by providing the downloaded data from an approved engine analyzer. This warranty is null and void if the aircraft in which the engine is installed does not have an approved and operational engine analyzer. Claims must be made to **Performance Engines, Incorporated** in writing, detailing the suspected problem. Performance Engines, Incorporated must be given the opportunity to inspect the engine and its installation before any disassembly or removal is initiated. Engine installation, transportation, storage, etc., is not covered by this warranty. This warranty shall be in effect only so long as this overhauled engine remains in the aircraft of record stated below, and is not transferable.*

PERFORMANCE ENGINES, INCORPORATED MAKES NO OTHER WARRANTY OF ANY KIND, EXPRESSED OR IMPLIED. IN NO EVENT SHALL PERFORMANCE ENGINES, INCORPORATED BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING BUT NOT LIMITED TO LOSS OF USE OF THE AIRCRAFT OR ENGINE OR DAMAGE TO PROPERTY, PERSONAL INJURY OR DEATH, TO ANY PERSON. (Some states do not allow the exclusion or limitations of incidental or consequential damages, so the above limitation or exclusion may not apply to you.)
